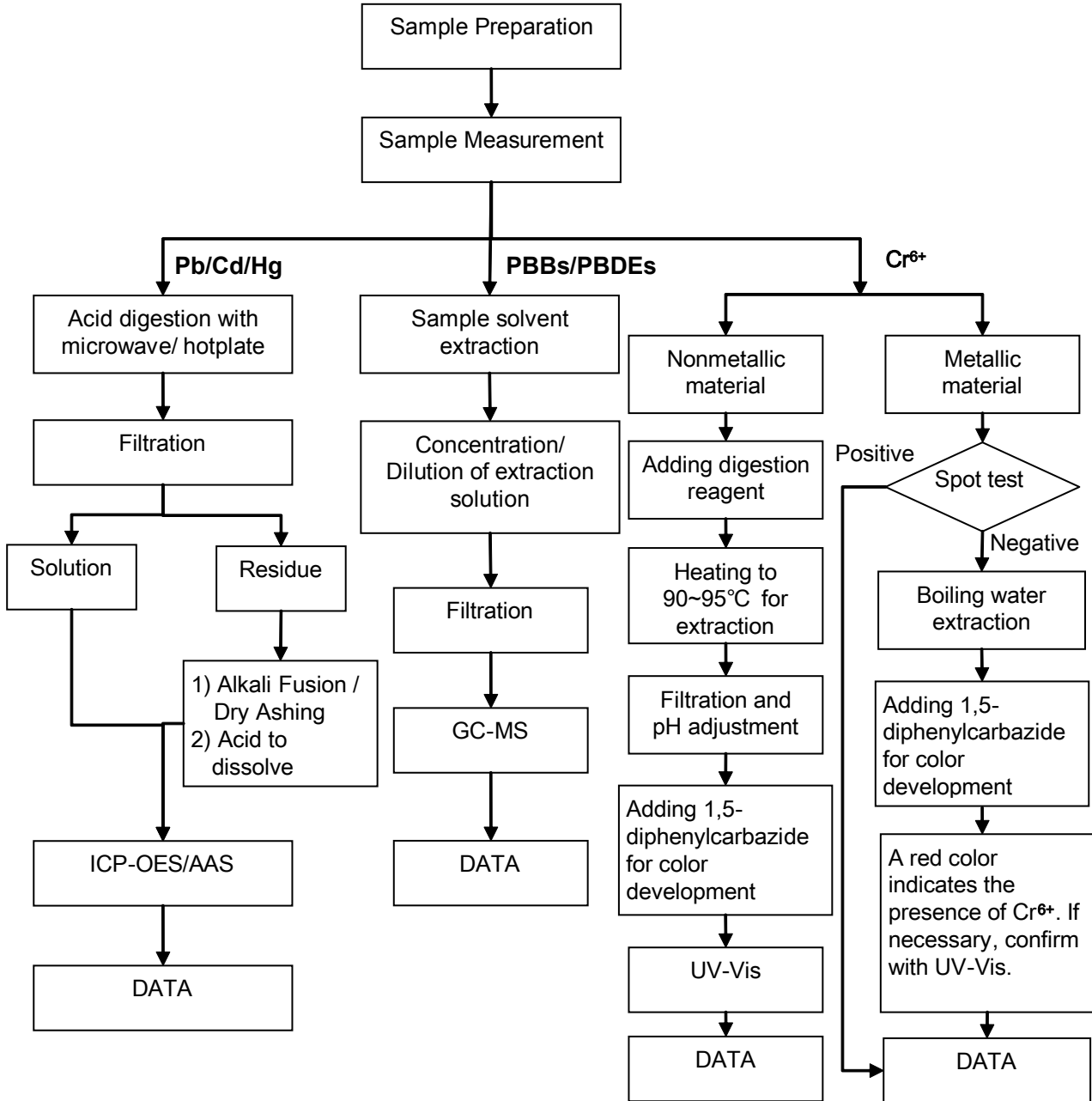

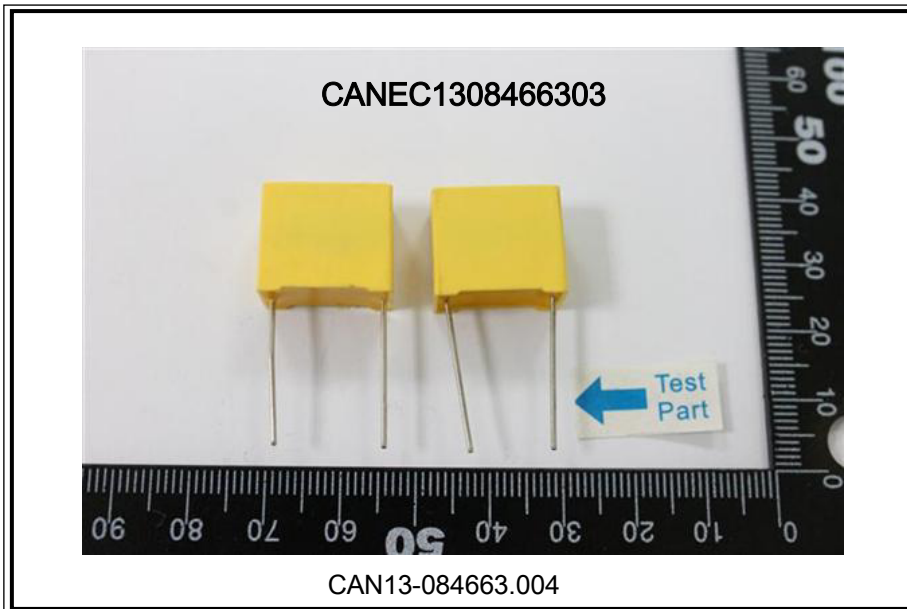
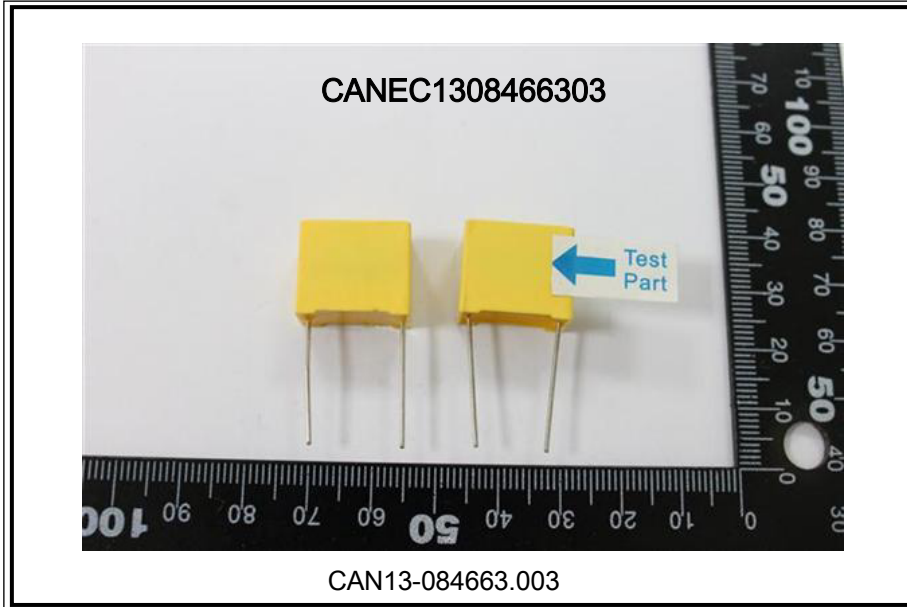
RoHS Testing Flow Chart

- 3) These samples were dissolved totally by pre-conditioning method according to below flow chart (Cr⁶⁺ and PBBs/PBDEs test method excluded).

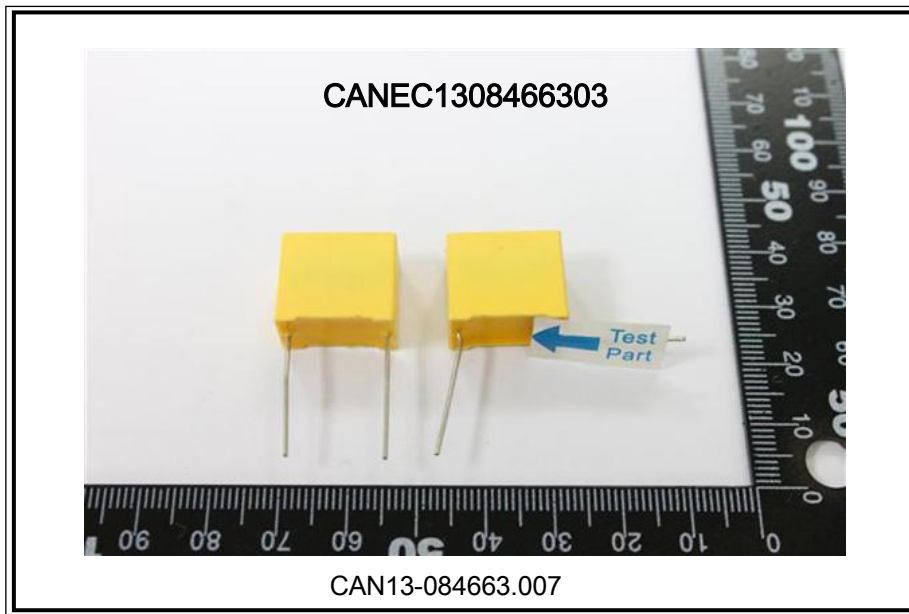
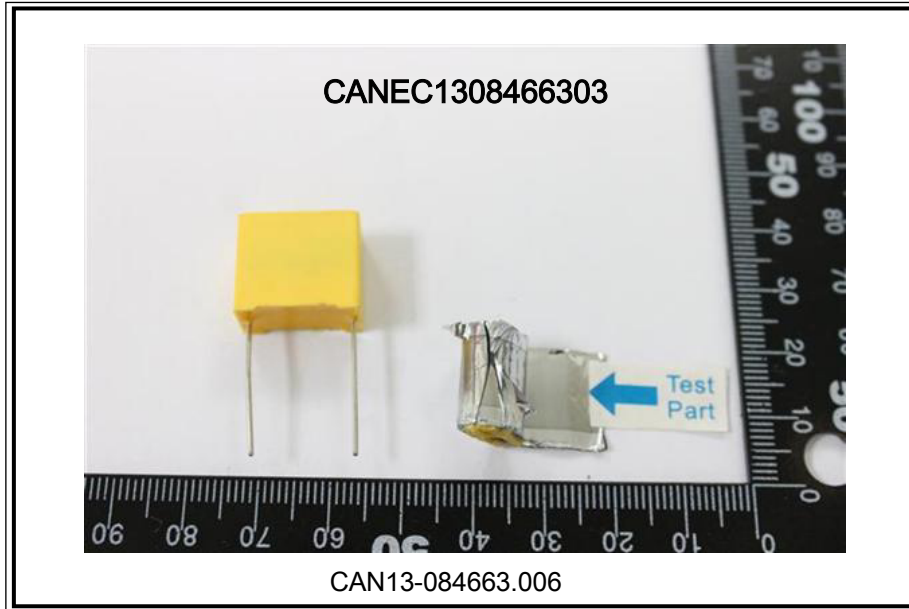
